

# Online CSA Question Gap Description

The Corporate Sustainability Assessment (CSA) scores, calculated by S&P Global, serve as an essential tool for companies to evaluate their sustainability performance and strategy. Beyond informing capital markets and stakeholders, these scores provide valuable insights for internal sustainability managers to assess their progress and make data-driven decisions. The Online CSA Question Gap Description Service supports the need for companies to understand the factors that impact a score change to inform the topic specialists in a timely manner.

## The service and what problem does this solve?

The service provides insights into understanding the CSA question score or a question score change year-over-year by describing the question expected practice and eventual discrepancies to the expected practice in an online format, directly on the CSA Platform.

- Access to the **Benchmarking Database (BDB) — Starter version**.

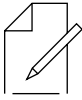

Understand the CSA expectations and eventual gaps on up to twenty CSA questions: missing or not validated information by the CSA analyst.



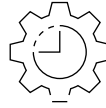
### Online ordering and delivery on the CSA Platform
